**WARNING:** I understand and accept that all forms of skiing, snowboarding and other winter mountain sports, including the use of lifts, in which I may participate at the Resort are hazardous with many inherent and other risks that can result in injuries and death. Falls and injuries are common occurrences. These activities require deliberate and conscious control through proper lookout, and care with due regard for ever changing variables and dangers. Safety is directly affected by participant judgment and attention in the mountain terrain. I agree to ski or ride ONLY within my ability and to follow **Your Responsibility Code**.

ASSUMPTION OF RISK: I freely and willingly accept and voluntarily assume all risk of property damage, personal injury, or death which may occur and which results from participating in winter sports activities and the inherent risks of such activities. I further agree that the phrase "inherent risks" means those risks, which are listed in this Agreement, or those that can reasonably be inferred therefrom. I also agree that these risks are both obvious and necessary to these winter sports activities and that these inherent risks include but are not limited to changing weather conditions, surface and/or subsurface snow conditions as they may from time to time exist and may change or be affected by weather, skier, or other participant usage, and whether such conditions are surface or subsurface or consist of ice, hard pack, powder, packed powder, wind pack, corn, crust, slush, cut up snow, and/or machine made or machine enhanced snow; other conditions including bare spots, forest growth and debris, stumps and trees, streambeds, water and/or water bars, other natural objects and/or collisions with such objects; collisions with others; collisions with lift towers, structures, signs, terrain park features and structures; posts, fences, or other enclosures; water and/or air pipes or other manmade structures, and/or their components such as hydrants used in snowmaking or for other necessary purposes; collisions with well-marked or plainly visible snowmobiles, snow grooming, and/or other over snow vehicles or equipment; variations in terrain that occur naturally or as the result of slope design, weather changes, snowmaking and/or snow grooming operations, or participant usage.

**PROMISE NOT TO SUE/HOLD HARMLESS/RELEASE:** In consideration of all of the above, I agree that I will not make any claim nor bring any suit for any damages, injury, or death which results from any such inherent risks as I have agreed to the terms defined herein. I hereby RELEASE, to the full extent allowed by law, Resort (including their officers, employees, affiliates, agents, etc.) from any and all liability for personal injury including death, and property damage including any alleged negligence in the operation of and/or maintenance of its premise, including but not limited to damages that arise from encountering of any of the above defined inherent risks. I also agree that in the event anyone makes any claim against the Resort or any of its officers, directors, shareholders, agents, and/or employees, as a result of any of my activity on their premises or the use of their facilities, that I will indemnify and hold the Resort harmless from such claims.

**FORUM SELECTION:** I further agree that any dispute arising out of my use of this Agreement and/or from any use by me of any of the premises or facilities at Jay Peak Resort shall be litigated exclusively in the Vermont Superior Court, Orleans Civil Division or the U. S. District Court for the District of Vermont.

This contract may be plead as an affirmative defense to any claim I might make as a result of any damage, injury, and/or death which I may sustain as a result of my participation in winter sports activities at Resort. I further agree that this contract is binding upon me, my heirs and assigns. To the extent that I am signing this document on behalf of a minor I represent and guarantee that I have full authority to do so, realizing the full binding effect of this contract on them as on myself. I further agree to indemnify and hold harmless Resorts for any claims brought on behalf of the minor relating to any damages allegedly sustained by the minor while he/she was in use of this pass. I also agree to abide by all policies and by the rules of conduct for sports participants posted at the Resort as contained in the seasonal trail maps, policies and/or brochures.
