WARNING

Alpine skiing/boarding, and all forms of winter activities ("Winter Activities") are hazardous and require the deliberate and conscious control of your physical body through proper use of alpine equipment in relation to ever-changing variables and dangers. Safety is directly affected by judgment in the severe elements of rough, high mountain forest terrain, skiing/riding within one's own abilities, following all safety policies and procedures, skiing/riding in control, and understanding and abiding by "Your responsibility Code." Be alert to continually changing weather, visibility and surface conditions. Snow, ice, sheer drop-offs, bare ground, rocks, roots, stumps, trees, lift towers, ruts, bumps, snowmaking equipment, grooming vehicles, snowmobiles, debris and conditions of any glade wooded areas, collisions with other skiers, design and conditions of natural and manmade terrain features, signposts, power poles and multitude of other objects are inherent to all forms of alpine activities. Be prepared to stop at all times. Never ski alone. Ski/board and participate in winter activities only on open/designated areas.

ACKNOWLEDGMENT OF RISK

I realize that accidents and injuries occur at ski areas and that many obstacles and hazards exist and that they may or may not be seen. I agree, as a condition of being allowed to use the ski area premises and facility, that I freely accept and voluntarily assume ALL risk of personal injury or death or property damage and I hereby agree not to make any claims against Jay Peak Resort or its associated divisions and resorts, its agents, employees, directors and officers for personal injury or death or property damage which results in any way from: conditions on or about the premises and facilities, the operation of the ski area, including but not limited to grooming, snowmaking, other ski area operations, natural and man-made obstacles or their placement, visibility or condition, action, or omissions of employees or agents of the area, or my participation in any form of skiing or any other activities at the area, accepting myself the full responsibility for any such damage or injury of any kind which may result.

I further understand that this is a contract that limits my legal rights, and it shall be binding upon heirs, my next of kin, executors, administrators and me. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect.
